Your municipal summons requires you to appear in person before the Municipal Court of Walnut Grove, Missouri at 1:30 p.m. on the date written at the top of the ticket.

UNLESS you wish to plead guilty to one of the above charges without appearing in Court and pay your fine in person Monday - Friday 9 AM to 5:00 PM at 101 S. Washington St. or online at www.walnutgrovemo.org and click on the link at the bottom of the home page. **Please allow ten (10) days for processing before attempting to pay your fine.**

Only those violations listed on this notice may be paid to the Court in advance. You must appear in Court if you were involved in an accident. If your violation is listed above and you wish to plead guilty without coming to Court or into City Hall:

1. Sign your name to the "Appearance Plea and Waiver" on the back of the summons.
2. Mail your signed ticket AND mail your check payable to the City of Walnut Grove OR pay online at www.walnutgrovemo.org and click on the link at the bottom of the home page.
